

CENTRE TOWNSHIP AND BOROUGH OF CENTERPORT

ORDINANCE # 7

AN ORDINANCE ADOPTING A COMPREHENSIVE PLAN.

BE IT ENACTED AND ORDAINED BY THE BOARD OF SUPERVISORS OF the Township of Centre in the County of Berks and Commonwealth of Pennsylvania, and the Borough Council of the Borough of Centerport, County of Berks and Commonwealth of Pennsylvania, and it is hereby ENACTED and ORDAINED by the authority of the same for the said Township and Borough.

WHEREAS, the Planning Commission of Centre Township and the Borough of Centerport have reported that they have thoroughly reviewed the geographic, economic facilities, background and potential of the Township and Borough and on the basis of their study recommend that the County Comprehensive Plan of Berks would ~~would~~ completely serve the Township and Borough and that they, therefore, recommend that the Township and Borough adopt the said Plan; and

WHEREAS, the Supervisors of Centre Township and the Council of the Centerport Borough have duly considered the aforesaid recommendation and find it to be sound and completely proper and would, in addition, effect a considerable saving to the taxpayers of the Township and Borough;

ARTICLE I. The Supervisors of Centre Township and the Council of Centerport Borough adopt by reference

insofar as its provisions apply to this Township and Borough the County Comprehensive Plan of Berks originally adopted August 22, 1967 and duly enacted and with slight modifications readopted by the County Commissioners on July 17, 1969, pursuant to the provisions of Act 247 of the 1968 Session of the General Assembly of the Commonwealth of Pennsylvania. The said Supervisors and Council adopt the County Comprehensive Plan and its basic elements as follows: (1) a statement of community objectives; (2) a plan for land use; (3) a plan for movement of people and goods; (4) a plan for community facilities and utilities; and (5) maps relating these elements to this Township and Borough, to the County and to surrounding counties.

ARTICLE II. That advertising and holding of a public hearing on JUNE 30, 1971 and all other provisions of the aforesaid Act 247 be pursued to effect the foregoing.

ARTICLE III. That enforcement and amendment of the Comprehensive Plan be effected as provided in the aforesaid Act 247.
