## ORDINANCE NO. /2/1996

AN ORDINANCE AMENDING ORDINANCE NO. 54-1991, KNOWN AS THE CENTRE TOWNSHIP CURB AND SIDEWALK ORDINANCE, ENACTED ON MAY 22, 1991, REGULATING THE GRADING OF SIDEWALK AREAS AND THE CONSTRUCTION AND REPAIR OF CURBS, SIDEWALKS, DRIVEWAY ENTRANCES, AND RETAINING WALLS, AND REQUIRING PERMITS THEREFOR, REQUIRING THE PLACEMENT OF SIGNS, BARRIERS, AND LIGHTS, PROVIDING FOR INDEMNIFICATION OF THE TOWNSHIP FOR LIABILITY; REQUIRING THE CONSTRUCTION OF CURB AND SIDEWALK UNDER CERTAIN CIRCUMSTANCES, PROVIDING PENALTIES AND REMEDIES FOR VIOLATION THEREOF; AND PROVIDING FOR REPEAL OF CERTAIN ORDINANCES; TO INCLUDE THE REQUIREMENT THAT SIDEWALK CONSTRUCTION AND REPAIR CONFORM TO THE REQUIREMENTS OF THE AMERICANS WITH DISABILITIES ACT AND THE PENNSYLVANIA UNIVERSAL ACCESSIBILITY ACT; AND THAT CURB CONSTRUCTION AND REPAIR CONFORM TO THE REQUIREMENTS OF THE AMERICANS WITH DISABILITIES OF THE AMERICANS WITH DISABILITIES ACT

BE IT ENACTED AND ORDAINED by the Supervisors of the Township of Centre, Berks County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

Section 1. That Ordinance No. 54-1991, known as the Curb and Sidewalk Ordinance, enacted May 22, 1991, be and hereby is amended by amending Section 1 as follows:

- (11) All sidewalk construction and repair shall be in conformity with the requirements of the Americans With Disabilities Act, 42 U.S.C. Section 12101, et seq., and all regulations and technical requirements of the same; and the Universal Accessibility Act, 71 P.S. Section 1455.1 et seq., and all regulations and technical requirements of the same.
- (12) All curb construction and repair shall be in conformity with the requirements of the Americans With Disabilities Act, 42 U.S.C. Section 12101, et seq. and all accompanying regulations and technical requirements of the same.

Section 2. Effective Date. This Ordinance shall become effective on the earliest date permitted by law.
