## CENTRE TOWNSHIP BERKS COUNTY, PENNSYLVANIA

## ORDINANCE No. 107-2003

AN ORDINANCE OF CENTRE TOWNSHIP, BERKS COUNTY, PENNSYLVANIA, DECREASING THE NUMBER OF MEMBERS ON THE CENTRE TOWNSHIP PLANNING COMMISSION FROM SIX TO FIVE; PROVIDING FOR A REPEALER, A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE

WHEREAS, the Centre Township Planning Commission was created by the Board of Supervisors of Centre Township by the enactment of Ordinance No. 100, on August 12, 2002; and

WHEREAS, Ordinance No. 100-2002 established membership on the Township Planning Commission to be comprised of six (6) members; and

WHEREAS, the Board of Supervisors desire to amend said Township Planning Commission membership to decrease the membership to five (5) members.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, by the Board of Supervisors of Centre Township, Berks County, Pennsylvania, and it is hereby ENACTED and ORDAINED by the authority of the same, as follows:

SECTION 1. <u>Membership</u>, <u>Powers</u>, <u>and Duties of the Township Planning Commission</u>. The Township Planning Commission, in accordance with Section 205 of the Municipalities Planning Code, 53 P.S. Section 10205, shall be comprised of five (5) members, and shall have powers and duties as determined by the Centre Township Board of Supervisors, including but not limited the powers and duties set forth in Section 209.1(a) of the Municipalities Planning Code, 53 P.S. Section 10209.1(a).

SECTION 2. Current Members. The current members of the Centre Township Planning Commission together with their applicable terms is attached hereto as Exhibit "A".

SECTION 3. Severability. If any section, sentence, phrase, paragraph, clause, term, or provision hereof is determined to be invalid, illegal, or unconstitutional by any court of competent jurisdiction or by any state or federal agency or regulatory authority having jurisdiction thereof, such determination shall have no effect on the validity of any other section, sentence, phrase, paragraph, clause, term, or provision hereof, all of which shall remain in full force and effect.

SECTION 4. Repealer. Section 4 of Ordinance 100-2002 is hereby specifically repealed. All other ordinances, or portions thereof, inconsistent herewith are hereby repealed.

SECTION 5. <u>Effective Date</u>. This Ordinance shall become effective in accordance with the law.
