

ORDINANCE NO. 129-2009

AN ORDINANCE OF CENTRE TOWNSHIP, BERKS COUNTY, PENNSYLVANIA, VACATING A CERTAIN PORTION OF PINE ROAD AT THE POINT WHERE PINE ROAD MEETS THE WESTERN PROPERTY LINES OF JOEL L. BROWN, 192 PINE ROAD, MOHRSVILLE, PA AND JOSEPH C. AND KAREN J. A. CRISAFULLI, 57 PINE ROAD, MOHRSVILLE, PA EXTENDING WESTWARD TO ITS INTERSECTION WITH PONY ROAD IN THE TOWNSHIP OF CENTRE

WHEREAS, in the judgment of the Board of Supervisors of the Township of Centre, Berks County, Pennsylvania, it is necessary and desirable to vacate a certain portion of road known as Pine Road at the point where Pine Road meets the western property lines of Joel L. Brown, 192 Pine Road, Mohrsville, PA and Joseph C. and Karen J.A. Crisafulli, 57 Pine Road, Mohrsville, PA extending westward to its intersection with Pony Road in the Township of Centre.

NOW, THEREFORE, BE IT ENACTED by the Board of Supervisors of the Township of Centre, Berks County, Pennsylvania, and IT IS HEREBY ENACTED AND ORDAINED by the authority of the same as follows:

Section 1. A portion of a certain road known as Pine Road at the point where Pine Road meets the western property lines of Joel L. Brown, 192 Pine Road, Mohrsville, PA and Joseph C. and Karen J.A. Crisafulli, 57 Pine Road, Mohrsville, PA extending westward to its intersection with Pony Road in the Township of Centre, as more fully depicted on Exhibit "A" attached hereto and incorporated herein by reference thereto, is hereby vacated as a public road.

Section 2. Notwithstanding the vacation by the Township of Centre specified in Sections 1 above, all easements heretofore granted over, through, across and under the real properties comprising that portion of Pine Road being vacated pursuant to Sections 1 above shall be maintained and all rights pertaining thereto shall remain in full force and effect.


Section 3. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Board of Supervisors of the Township of Centre that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

Section 4. All ordinances or parts of ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance.


Section 5. This Ordinance shall become effective in accordance with the law.

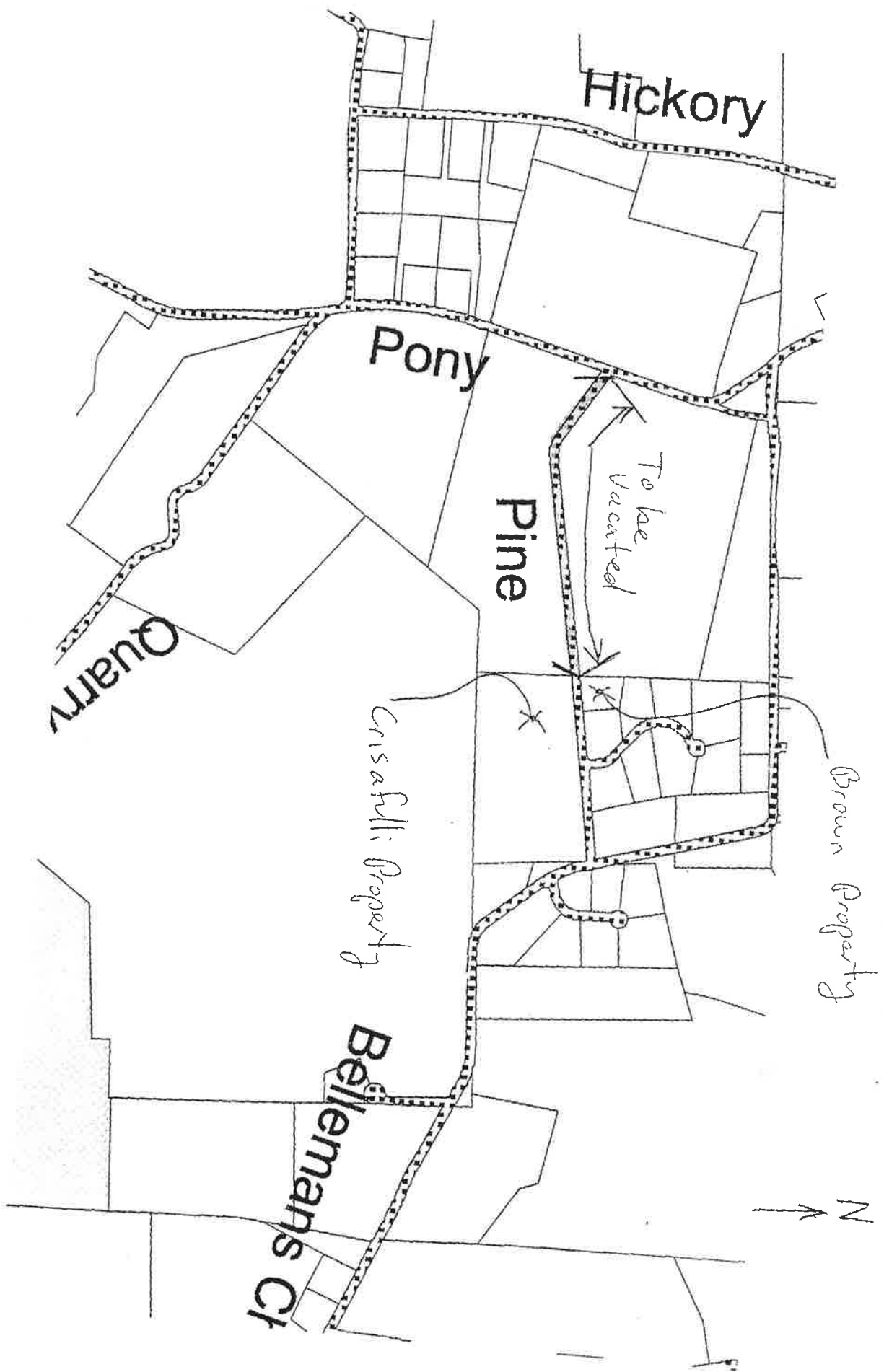
