

ORDINANCE NO. 83, 1999

AN ORDINANCE OF THE TOWNSHIP OF CENTRE, BERKS COUNTY, PENNSYLVANIA AMENDING ORDINANCE NO. 26A-1993 OF THE TOWNSHIP OF CENTRE, AS AMENDED, PROVIDING FOR THE REGULATION OF TRAFFIC AND PARKING IN THE TOWNSHIP, GENERALLY, AND SPECIFICALLY HEREIN PROVIDING FOR SPEED LIMITS AND RELATED MATTERS PERTAINING TO BOAR ROAD, GIN MILL ROAD, PARK ROAD, ERNST DRIVE, SOUTH GARFIELD ROAD, NORTH GARFIELD ROAD, JUNGLE ROAD, WINTER HILL ROAD, PHILLIPS ROAD, LESHER MILL ROAD, MANOR DRIVE, IRISH RUN ROAD, VICTORIA DRIVE, KOCHER DRIVE, KISSINGER AVENUE, GRIM AVENUE AND SHORE DRIVE PURSUANT TO SPEED LIMIT EVALUATIONS AS DULY PERFORMED BY THE TOWNSHIP ENGINEER

BE IT ENACTED AND ORDAINED by the Supervisors of the Township of Centre, Berks County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

**Section 1.** Section 8 of Ordinance No. 26A-1993 governing maximum speed limits established on portions of certain roads, or for the entire length of certain roads, is hereby amended and restated by adding speed limits governing certain roads and affirming speed limits governing other roads, as follows:

"Section 8. Maximum Speed Limits. Maximum speed limits are established on portions of certain roads, or for the entire length of certain roads, as follows, and it shall be unlawful for any person to drive a vehicle on any part of a road where a maximum speed limit applies, at a higher speed than the maximum prescribed for that road or portion of the road as set forth below:

**Section 2. Repeal of Certain Prior Ordinances.** All prior ordinances of the Township of Centre, insofar as they deal with maximum speeds on the roads referred to in Section 1 above are hereby repealed and declared unenforceable insofar as they are inconsistent with or identical to any provision of this Ordinance.

**Section 3. Effective Date.** This Ordinance shall take effect on the earliest date allowed by law.
