ORDINANCE NO. 2022-171

AN ORDINANCE OF THE TOWNSHIP OF CENTRE, BERKS COUNTY, PENNSYLVANIA, AMENDING CENTRE TOWNSHIP ORDINANCE NO. 129-2010 ENTITLED "AN ORDINANCE AUTHORIZING THE TOWNSHIP OF CENTRE, BERKS COUNTY, PENNSYLVANIA, ELECTING TO ADMINISTER AND ENFORCE THE PROVISIONS OF THE PENNSYLVANIA CONSTRUCTION CODE ACT, ACT 45 OF 1999, 35 P.S. §§7210.101 - 7210-1103." TO REQUIRE NEW NON-RESIDENTIAL BUILDINGS, NON-RESIDENTIAL BUILDINGS WHERE NEW CONSTRUCTION RESULTS IN A PHYSICAL CHANGE, AND NON-RESIDENTIAL BUILDINGS WHERE A CHANGE OF USE OR OCCUPANCY CLASSIFICATION OCCURS TO INSTALL KEY BOXES

WHEREAS, by enacting Ordinance Number 129-2010 on May 10, 2010 the Township of Centre elected to be an opt-in municipality in the Commonwealth of Pennsylvania selecting to enforce the Pennsylvania Construction Code Act, Act 45 of 1999, 35 P.S. §7210.101-7210.1103, as amended ("Act") and the Uniform Construction Code, 34 Pa. Code, Chapters 401-405, as amended ("Code") through the means set forth therein; and

WHEREAS, effective February 14, 2022 the Commonwealth of Pennsylvania has elected to enforce the 2018 versions of the International Codes as part of the Uniform Construction Code; and

WHEREAS, the Uniform Construction Code is interpreted to adopt the International Fire Code only as referenced in the International Building Code; and

WHEREAS, Section 506 of the 2018 version of the International Fire Code set forth requirements for the installation of key boxes in certain structures for use by the fire code official; and

WHEREAS, the International Building Code and thus the Uniform Construction Code does not adopt Section 506 of the 2018 International Fire Code; and

WHEREAS, Section 503(c) of the Act, 35 P.S. §7210.503, allows opt in municipalities to enact an ordinance to equal or exceed the minimum requirements of the Code upon compliance with the procedures set forth in Section 503(d) through (i) of the Act, 35 P.S. §7210.503(d)-(i); and

WHEREAS, the Board of Supervisors for the Township of Centre desires to amend its adoption of the Uniform Construction Code to require the installation of key boxes in new non-residential buildings for use by the fire code official.

NOW THEREFORE BE IT ENACTED and ORDAINED by the Board of Supervisors of the Township of Centre, Berks County, Pennsylvania by the authority of the same as follows:

SECTION 1. Ordinance Number 129-2010 is hereby amended to add a new Section 2A, entitled

"Amendments".

<u>Section 2.</u> Ordinance Number 129-2010, Section 2A entitled "Amendments" is hereby amended to add subsection "A" entitled "Key Boxes", which shall read in its entirety as follows:

A. Key Boxes:

- **a.** Where required. Where access to or within a structure or an area is restricted because of secured openings or where immediate access is necessary for life-saving or fire-fighting purposes, the fire code official is authorized to require a key box to be installed in an approved location. The key box shall be of an approved type listed in accordance with UL 1037, and shall contain labeled keys, easily identified in the field, to gain necessary access as required by the fire code official.
- **b.** Applicable Structures. This section applies to the following structures:
 - 1. new non-residential buildings;
 - 2. existing non-residential structures where new construction resulting in a physical change to the structure occurs; and
 - 3. existing non-residential structures where a change of use or occupancy classification occurs.
- **c. Key box maintenance.** The operator of the building shall immediately notify the fire code official and provide the new key where a lock is changed or rekeyed. The key to such lock shall be secured in the key box.

SECTION 3. Other UCC Modifications.

Any other modification to the UCC that equals or exceeds the UCC requirements for buildings adopted on or before July 1, 1999 shall remain in full force and effect.

<u>SECTION 4.</u> Repeal of Ordinances.

Any ordinance or part of ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance's provision.

SECTION 5. Severability.

If any article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase or word in this Ordinance, is, for any reason declared to be illegal, unconstitutional or invalid, by any Court of competent jurisdiction, this decision shall not affect or impair the validity of the Ordinance as a whole, or any other article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase, word, or remaining portion of the within Ordinance. The Board of Supervisors of the Township of Centre, Pennsylvania, hereby declares that it would have adopted the within Ordinance and each article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase and word thereof, irrespective of the limitations.

restrictions, sentences, clauses, phrases, or word that may be declared illegal, unconstitutional or invalid.

SECTION 6. Effective Date.

The effective date of the within amendments, except where longer period is otherwise provided for, shall be thirty-five (35) days after its enactment.
