

CENTRE TOWNSHIP, BERKS COUNTY, PENNSYLVANIA

ORDINANCE NO 2019 - 164

AN ORDINANCE OF THE TOWNSHIP OF CENTRE, BERKS COUNTY, PENNSYLVANIA, REPEALING THE CENTRE TOWNSHIP PER CAPITA TAX ORDINANCE, TO ELIMINATE THE IMPOSITION AND COLLECTION OF A PER CAPITA TAX IN CENTRE TOWNSHIP.

WHEREAS, on December 13, 1972, by Ordinance No. 11, known as the “Centre Township Per Capita Tax Ordinance,” the Board of Supervisors of Centre Township established a per capita tax in Centre Township, imposing an annual tax upon each and every adult resident of Centre Township, Berks County, Pennsylvania; and

WHEREAS, the said per capita tax has been amended from time to time by ordinance or resolution of Centre Township; and

WHEREAS, the Board of Supervisors of Centre Township has determined that it is in the best interests of the Township to repeal the said Centre Township Per Capita Tax Ordinance, as amended, to eliminate the per capita tax in Centre Township.

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Centre, Berks County, Pennsylvania as follows:

Section 1. Repeal of Per Capita Tax.

Under authority of the Local Tax Enabling Act, 53 P.S. § 6924.101 *et seq.*, and other applicable law, that Centre Township Ordinance No. 11, as amended, known as the “Centre Township Per Capita Tax Ordinance”, is hereby repealed in full, effective as of January 1, 2019.

Section 2. Severability.

If any section, subsection, clause, sentence, paragraph or part of this Ordinance shall, for any reason, be adjudged by a court of competent jurisdiction to be invalid, illegal, or unconstitutional, such invalidity, illegality or unconstitutionality shall not affect, impair or invalidate the remaining provisions of this Ordinance. It is hereby declared to be the legislative intent of the Board of Supervisors that this Ordinance would have been adopted had such provisions not been included herein.

Section 3. Repeal of Ordinances.

Any ordinances or parts of ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance’s provisions.
