WHEREAS, the Township of Centre is organized as second class township in the Commonwealth of Pennsylvania; and

WHEREAS, as a second class township in the Commonwealth of Pennsylvania, the Township of Centre is governed by the Pennsylvania Second Class Township Code; and

WHEREAS, pursuant to Section 2204 of the Pennsylvania Second Class Township Code, 53 P.S. 67204, a recreation board is to be created by ordinance of the board of supervisors; and

WHEREAS, the Board of Supervisors of the Township of Centre desires to abolish the Township Recreation Board; and

WHEREAS, in consideration that an Ordinance is required to create a recreation board in a Second Class Township, the Board of Supervisors opines that an Ordinance is necessary to abolish a township recreation board.

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Centre, Berks County, Pennsylvania as follows:

SECTION 1. Abolishment of Recreation Board.

The Township of Centre Recreation Board is hereby abolished, terminated and disbanded.

SECTION 2. Repeal of Ordinances and Resolutions.

Any ordinance or resolution, specifically Ordinance 80-1998, or part of ordinances or resolutions conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance.

SECTION 3. Severability.

If any article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase or word in this Ordinance, is, for any reason declared to be illegal, unconstitutional or invalid, by any Court of competent jurisdiction, this decision shall not affect or impair the validity of the Ordinance as a whole, or any other article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase, word, or remaining portion of the

within Ordinance. The Board of Supervisors of Centre Township, Berks County, Pennsylvania, hereby declares that it would have adopted the within Ordinance and each article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase and word thereof, irrespective of the limitations, restrictions, sentences, clauses, phrases, or word that may be declared illegal, unconstitutional or invalid.

SECTION 4. Effective Date.

This Ordinance shall become effective five (5) days after enactment, as provided by law.
